

## TACTICAL UNCONSTRAINED

Tactical Unconstrained<sup>®</sup> asset allocation approaches remove the limits on the extent and frequency of allocation shifts, allowing the portfolio strategist to move more aggressively in response to changes in outlook. These approaches can provide flexibility for "rowing" markets when headwinds place a premium on active asset class management.

# TACTICAL CONSTRAINED

Tactical Constrained<sup>®</sup> approaches attempt to capture broad market returns while also seeking to take advantage of shorter-term opportunities or mitigate risks through moderate allocation shifts. These approaches may also put the positive winds of "sailing" markets to work in client portfolios, but they also create the potential for the portfolio strategist to add additional value through active, near-term allocation decisions.

Absolute Return strategies are for risk-averse investors comfortable with modest returns in exchange for highly active risk management that may include frequent allocation shifts, non-traditional asset classes and/or alternative strategies. These strategies are designed to help clients "row" toward their financial goals regardless of the stock market's direction.

#### **ADMINISTRATIVE ACCOUNTS**

**General Securities:** An unmanaged account for holding general securities that will be transitioned into managed strategies over time. Fees must be debited via ACH or related account.

**Cash Alternative:** An unmanaged account for holding cash in a general money market vehicle available on the platform. **Custodial Sweep Account:** An unmanaged account in which a client may elect to hold cash in available custodial money market options.

- <sup>1</sup> The platform fee varies depending on the size of the account; smaller accounts will pay the maximum fee shown. The platform fee does not include any additional fees that may be charged by BD firms with supervisory responsibility over the RIA activities of their representatives.
- <sup>2</sup> The Consolidated Managed Accounts fee includes investment management firm fees.
- <sup>3</sup> Asset-based pricing schedule for most equity managers begins at 0.25-0.27% for first \$250,000 per manager account, and scales down to 0.05-0.07% for larger accounts. Pricing for fixed income and balanced management firms, as well as certain "highturnover" equity management firms, will vary from this schedule.
- <sup>4</sup> Minimums may vary by manager.
- <sup>5</sup> Client accounts invested in investment solutions using the GuideMark Funds, GPS strategies or alternative strategies are invested in mutual funds for which AssetMark or its affiliate, Altegris Advisors, LLC, acts as investment adviser. AssetMark and Altegris

will receive fees from the mutual funds in which these accounts invest. The mutual fund fees differ between funds and the total fees collected will vary depending upon the profile selected by the client and the fund allocation within each profile. - <sup>6</sup> The Individually Managed Accounts fee schedule does not include investment management firm fees, which typically range from 0.35-0.40% per year for fixed income portfolios (with the exception of Eaton Vance Laddered which has a 0.16% manager fee) and 0.35 - 0.60% per year for equity/balanced portfolios. The Consolidated Managed Accounts (CMA) fee includes investment management firm fees.
- <sup>7</sup> ARO and GMS charge an investment manager fee of 0.60% at all levels.
- $^{\rm 8}$  Custody fee of 0.25% 0.05% is only applicable to the ETF billable assets held in the account.
